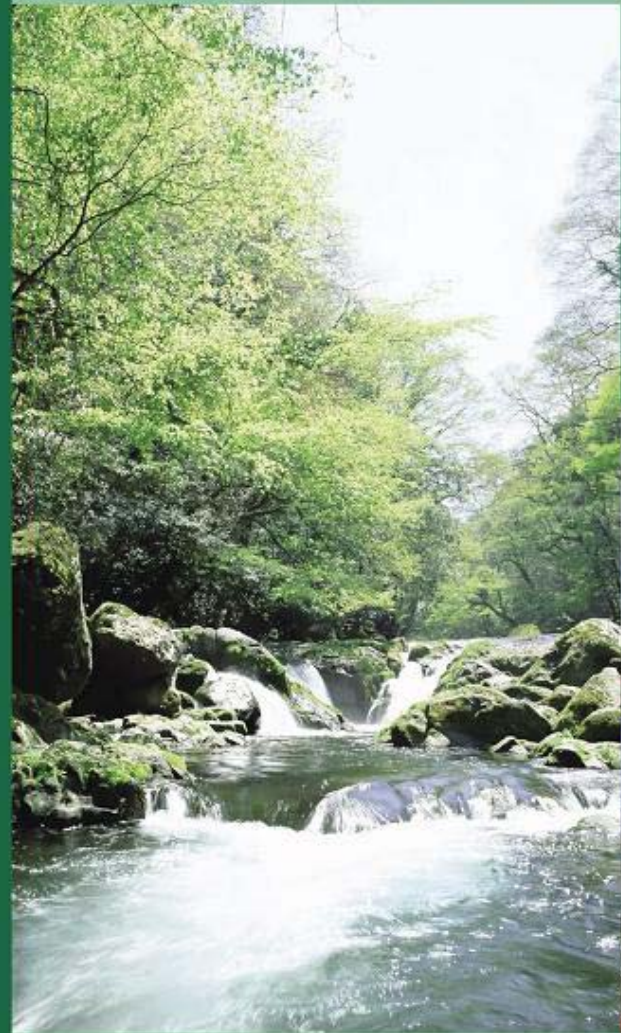

BACKGROUND TO FORUM

- UK DTI launched a strategy for Carbon Abatement Technologies (CAT) for fossil fuels in June 2005
- UK has the lead of G8 and EU in 2005 - Global Climate Change and engagement of Emerging Market Economies is high on the agenda
- EC is currently setting the Energy RTD agenda for FP7; EU Technology Platform ZEFFPP launched; FENCO underway
- Other CAT initiatives - nationally (eg Australia, Canada, Germany, Norway, Spain, US) and internationally (CSLF).

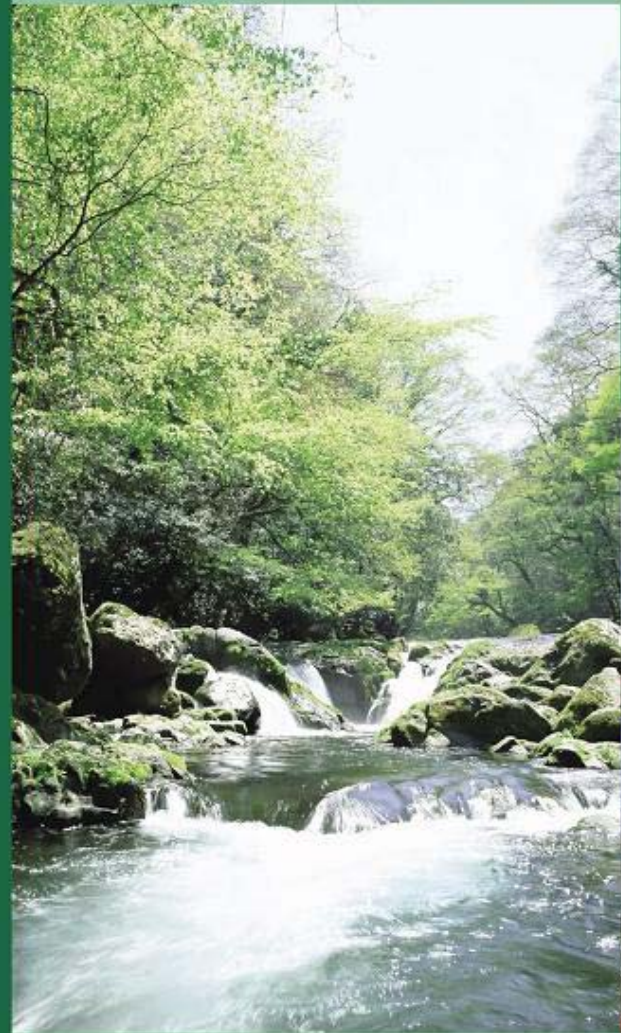
